

The California Franchise Tax Board confirmed that most Californians have until November 16, 2023, to file and pay their tax year 2022 taxes to avoid penalties. The IRS announced that taxpayers affected by winter natural disasters in 55 California counties qualify for an extension to file and pay their tax year 2022 federal income taxes until November 16, 2023.
